

**The Essex County Council (Tendring District) (Prohibition of Waiting, Loading and Stopping) and (On-Street Parking Places) (Civil Enforcement Area) (Amendment No.42) Order 2024**

**Notice is hereby given** Colchester City Council acting on behalf of the North Essex Parking Partnership in exercise of the delegated powers of the traffic authority Essex County Council granted under an Agreement dated 1<sup>st</sup> July 2022 proposes to make the above Order under Sections 1(1), 2(1) to (3), 4 (1), 4(2), 32, 35,45,46,49 and 53 and Parts III and IV of schedule 9 of the Road Traffic Regulation Act 1984

**The effect of the Order:**

To introduce no stopping at any time restrictions on Old Ipswich road, Crown Lane North and on the Access Road to The Beeches, The Cedars and the Oaks (Ardleigh); to introduce Limited Waiting for cars only 6 hours no return within 1 hour on Old Ipswich road.

To Revoke the No Waiting At Any Time restrictions on the East and West sides of Old Ipswich Road Ardleigh.

To Revoke the No Loading At Any Time on the West side of Old Ipswich road, Ardleigh.

The Essex County Council (Tendring District) (Prohibition of Waiting, Loading and Stopping) and (On-Street Parking Places) (Civil Enforcement Area) Consolidation Order 2019 shall be amended in so far as it relates to the stopping restrictions detailed in this Notice by: Replacing the following Map Tiles: TM020 292 revision 0 replaced by TM020 292 revision 1 TM020 290 revision 0 replaced by TM020 290 revision 1 TM020 287 revision 0 replaced by TM020 287 revision 1

**WHEREAS** Colchester City Council acting on behalf of the North Essex Parking Partnership in exercise of the delegated powers of the traffic authority Essex County Council granted under an Agreement dated 1<sup>st</sup> July 2022 in exercise of its powers under Sections 1(1), 2(1) to (3), 4(1), 4(2), 32, 35, 45, 46, 49 and 53 of and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 (“the Act”) and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act hereby makes the following Order:-

1. The Essex County Council (Tendring District) (Prohibition of Waiting, Loading and Stopping) and (On-Street Parking Places) (Civil Enforcement Area) (Amendment No.42) Order 2024 and shall come into operation on .....
2. This Order will be incorporated into The Essex County Council (Tendring District) (Prohibition of Waiting, Loading and Stopping) and (On-Street Parking Places) (Civil Enforcement Area) Consolidation Order 2019 ‘the 2019 Order’ by:

a. replacing the following Map Tiles:

TM020 292 revision 0 replaced by TM020 292 revision 1  
TM020 290 revision 0 replaced by TM020 290 revision 1  
TM020 287 revision 0 replaced by TM020 287 revision 1

3. The Map Schedule Legend to this Order only applies to the Map Tiles listed in this Order.
4. The prohibitions and restrictions imposed by this Order shall be in addition to and not in derogation from any restrictions or requirement imposed by regulations made or having effect as if made under the Act or by any other enactment.

**Old Ipswich Road, Ardleigh**

**Statement of Reasons**


Following local concerns about parking North Essex Parking Partnership implemented an experimental traffic order (Amendment No.25) in 2022.

The proposal is to make these restrictions permanent.

The proposal consists of a No Stopping At Any Time (red route) restriction to prevent parking and so ensure sight lines remain clear and for avoiding danger to persons or other traffic using Old Ipswich Road, Ardleigh and adjoining road junctions. Crown Lane North, The Beeches, The Cedars and The Oaks.

Preventing the likelihood of any such danger arising and for facilitating the passage of any class of traffic.

Limited Waiting bays in two areas of Old Ipswich Road. These will allow the opportunity to park for up to 6 hours with no return within 1 hour to accommodate visiting properties in the vicinity.
